As informed to us by the Management, the Notice dated June 29, 2021 convening the 67th Annual General Meeting of the Company through VC / OAVM held on August 25, 2021 along with the statement setting out material facts under Section 102 of the Companies Act, 2013 and MCA / SEBI Circulars were duly sent to the Members of the Company through electronic mode to those Members whose email addresses are registered with the Company / Depositories, in compliance with the above mentioned MCA and SEBI Circulars.

The Members of the Company holding shares on the record date ("Cut off" date) as on Wednesday, August 18, 2021 were entitled to vote on the resolutions as set out in the Notice of said 67th Annual General Meeting.

In this regard, we hereby submit our report as under:

- 1. The Company had availed the e-Voting facility offered by National Securities Depositories Limited ('NSDL') for conducting remote e-voting prior to AGM and evoting during AGM by the Shareholders of the Company.
- The remote e-Voting prior to AGM period remained open from Sunday, August 22, 2021 at 9.00 a.m. (IST) till Tuesday, August 24, 2021 at 05.00 p.m. (IST) and NSDL e-voting module was disabled thereafter.
- 3. The Company had also provided e-Voting facility to the shareholders present / logged-in at the AGM through VC / OAVM and who had not cast their vote earlier.
- After the closure of remote e-Voting at the AGM, we have unblocked the electronic votes for both remote e-Voting processes in the presence of two witnesses who are not in the employment of the Company.
- 5. We have scrutinized the votes cast through remote e-Voting and e-Voting during AGM, processes for the purpose of this report.
- The particulars of all the electronic votes cast by the members through remote e-Voting and e-Voting during AGM processes have been recorded in the register maintained for the purpose.


